On Saturday morning April 11, 2020 I posted on social media pages Facebook, Next Door Bulle Rock, This is Havre de Grace, You Know You're from Havre de Grace informing people of the scheduled meeting in a time of pandemic. That evening at 6:55 pm Lyle Sheldon corresponded with every elected official from the county to state level but excluded every municipal elected official. One of his comments was "In closing thank you for your continued support of UM UHC's comprehensive health care delivery plan; and we ask that you take no direct action as requested by the City of Havre de Grace leadership."

Isn't it amazing that the letters written in support of UM UHC all had the same catch phrase: While you, and perhaps the MHCC Commissioners themselves, may have received concerned letters and/or calls from select elected officials and a small number of the public, I think it's important for you to be aware, that those opinions and concerns are not shared consistently across the majority of elected officials here in the County nor myself as County Executive. The dramatization that is taking place, and framed within the context of this COVID-19 pandemic is inappropriate and inaccurately presented on many fronts.

Accusing the leadership of Havre de Grace of using the cover of the pandemic crisis as a cover. The true inappropriate actions were by the MHCC and UMHCH in scheduling a meeting when no-one was watching.

I never received a response from any member of the MHCC, UMUCH or the elected officials to my questions and concerns. To Lyle Sheldon and cc'd MHCC and all elected county and state officials for Baltimore/Harford, Harford and Harford/Cecil counties. As you stated you have been working over the last several years for the transformation of health care in Harford County however UM UCH is not working to maintain the health care needs of the community as a priority.

Why now? Both Harford County Hospitals are unable to keep pace with the current demand for patient care. Looking at the CHATS Region III report for January 2020 prior to the pandemic, Harford Memorial Hospital (UMUCH) had 13 Yellow Alerts with an average of 5.18 hours and total hours of 67.32, Red Alert 11, with an average of 17.16 hours and a total of 188.78 and Re-Route 6, average hours 1.08 and total of 6.5 hours.. Upper Chesapeake Medical Center (UMUCH) had 22 Yellow Alerts with an average of 14.80 hours and total hours of 325.67, Red Alert 7, with an average of 27.27 hours and a total of 190.89 and Re-Route 34, average hours 1.40 and total of 47.44 hours.

What is the rush in moving forward on the closing one of the two hospitals in Harford County?

Why isn't the MHCC waiting to see what the future structure of health care will become?

As you stated the information you are operating is several years old and did not consider a pandemic. I believe it is time to re-evaluate the facts based on the new information of the negative impact this pandemic has had on our current health care infrastructure and the proper way to respond for future health care delivery. It is the wrong time to make such an important and permanent decision.

- The City of Havre de Grace found out by chance on April 10th that next week on April 16th, the Maryland Health Care Commission will be voting on the University of Maryland Upper Chesapeake Health Care System's Application to shut down Harford Memorial Hospital and replace it with a Free Standing Medical Facility one that will not provide acute care services and only limited emergency services. I am concerned that you would move forward with such a request at this time given the ongoing global pandemic.
- It has always been my hope for the "hospital" to remain in Havre de Grace. We have had a long standing relationship with Harford Memorial Hospital and it has been a huge part of our community, serving our community for over 100 years. However, Upper Chesapeake has contended that a full service hospital is no longer a viable option. While I am not a subject matter expert on healthcare, I find it hard to believe that as our region continues to grow, only "one" full service hospital can adequately serve the needs of Harford and western Cecil County. This is especially true when you consider the location of Aberdeen Proving Ground (and what they do each and every day is inherently dangerous given the myriad of testing conducted), the I-95 corridor and the countless accidents that occur each and every day, the closing of Kirk Army Hospital, the ongoing drug problems/concerns, the countless nursing homes and assisted living facilities in the area, and any potential for a pandemic situation.



Yellow Alert: The emergency department temporarily requests that it receive absolutely no patients in need of urgent medical care.
Red Alert: The hospital has no ECG monitored beds available. These ECG monitored beds will include all in-patient critical care areas and telemetry beds.

Re-Route: This policy provides guidelines for both emergency medical services (EMS) and emergency medical dispatch (EMD) personnel when a basic or advanced life support unit is being held at a hospital emergency department because a bed is unavailable.

In response to your statement "For those who spotlight this pandemic as the key driver to halt our multi-year progressive plan at regionalizing health care in our community, there is an outright neglect in remembering the critical drivers for the need to transform health care in Harford County as well as within the state of Maryland." In a recent Washington Post report, Dr. David Marcozzi, a professor and physician who is leading the COVID-19 response for UMMS, stated "the health care systems across the country contracted as a result of trying to provide more efficient care... but if you contract the system, then when you have a surge, you are squeezed." He added, "You don't have enough beds open and nurses waiting to provide care."

I and the constituents I represent are not happy with the closing of 1 of the 2 hospitals serving the citizens of Harford and Cecil Counties.
