Proposed Budget Amendment 2021-13

The 2021 Budget includes \$228,600 to initiate the water line extension along Route 40 into Aberdeen. The 2021 funding was designed to cover the engineering estimate and advertising for construction.

The project is being funded entirely through the February 2021 Bond Issue approved by the citizens. The project estimate submitted for funding was \$4,116,600. This would leave \$3,888,000 for construction and oversight.

The City has issued an RFP for Phases 1 and 2 construction and is awarding the project to the low qualified bidder, for \$1,990,000, see the attached notification. We anticipate an additional \$260,000 in awards for this project, for a current estimate to complete totaling \$2,250,000. This will allow \$1,638,000 to be used for another approved project to be bond financed.

The plan is to begin the work before year end and I am therefore requesting we establish \$1,990,000 in additional funding under account 09-1232-9051 [Water Main Replacement – Route 40]

The funding will be accomplished through an increase to revenue account 09-0001-49-27 [DHCD Bond Funding]. The City has budgeted \$5,448,500 of the \$9,500,000 awarded. This amendment will reduce the unbudgeted bond funds for the fiscal 2021 bond issue to \$2,061,500. Additionally, the City has \$5,500,000 that can be used for additional projects anticipated for fiscal years 2024 and 2025.
