33 BE IT ORDAINED, that Chapter 25, Article XVI Havre de Grace Housing Authority is hereby
34 amended as follows:

36 **Article XVI Havre de Grace Housing Authority**

38 **§ 25-97 Appointments; terms, reappointment.**

40 The Mayor shall appoint each Commissioner for a five-year term. The terms shall be staggered.
41 Any Commissioner may be selected for reappointment by the Mayor. Each Commissioner
42 must take an oath of office before the Mayor and City Council or alternatively before any
43 Notary Public as required by the City Charter.

45 **NOW, THEREFORE**, it is determined, decided, and ordained by the City Council that the
46 foregoing amendments to the City Code are hereby approved.
