 approved by the Mayor and City Council of Havre de Grace, Maryland, on September 6, 2016;

- WHEREAS, the Independence Day 2017 Commission was reestablished in 2017, by Resolution
 2017-08 and approved by the Mayor and City Council of Havre de Grace, Maryland, on September
- 5, 2017, as the Independence Day 2018 Commission having the same purpose and duties as the

- WHEREAS, the Independence Day 2018 Commission continued its best efforts to become self funded, and that the Commission's 8 members whose terms were to expire on September 6, 2018.
- 45 were reappointed by the Mayor and City Council of Havre de Grace, Maryland for three additional
- 46 years to include calendar years 2019, 2020 and 2021 which was passed on August 20, 2018 by

- WHEREAS, Resolution 2018-16 stated that six months prior to the expiration of their terms, the Independence Day 2018 Commission shall advise the City of Commissions status, and whether the Commission shall be extended, converted to a permanent City Commission, or replaced with a new tax-exempt 501(c)(3) corporation; and

54 WHEREAS, the Independence Day 2018 Commission have determined and requested to maintain 55 continuity and continue to promote the Independence Day Celebration as a signature event in the 56 City of Havre de Grace that the Mayor and City Council of Havre de Grace create a permanent 57 Independence Day Commission.

59 NOW THEREFORE, it is determined, decided, and ordained by the City Council that it is in the 60 best interest of the citizens of Havre de Grace, that the Mayor and City Council of Havre de Grace 61 create a permanent Independence Day Commission, and will establish and include the same in 62 Section 25 of the City Code, New Article IX as follows:

SECTION 25 – New ARTICLE IX

66 The Independence Day Commission (hereafter referred to as the "Commission") is hereby 67 established.

69 § 25-50 Purpose.

70 The purpose of the Commission is to coordinate the planning, preparation, organization and 71 execution of an annual Fourth of July Celebration in the City of Havre de Grace.

§ 25-51 Organization and members.

- A. The Commission shall consist of not less than seven (7) volunteer members, each shall serve
 for a period of three (3) years from appointment.
- B. Non- volunteer support members of the Commission shall include: the Council President or
 the Council President's designee, the Chief of Police or the Chief's designee, the Manager of

Tourism, the Director of Administration or the Director of Administration's designee, and the
Director of DPW or the Director of DPW's designee.
§ 25-52 Officers; proceedings; quorum.

- A. The Commission shall be chaired by a volunteer member, who shall be responsible for the
 convening of each meeting.
- B. The Commission shall adopt its own rules as necessary and keep an accurate record of the
 proceedings as consistent with the City of Havre de Grace's Charter and Code, as well as the
 Maryland Open Meetings Act. The rules of procedure shall be kept by the Chairperson, and
 be made available at any time for public view.
- C. A quorum at any meeting shall be a minimum of any four of the volunteer members, including
 the Chair or the Chair's designee and one representative of the City's Staff.

94 § 25-53 Appointment of members, terms and replacement.

- A. Citizen Members. The Mayor, with the advice and consent of the City Council, shall appoint 95 96 all citizen members. The initial appointment for these members shall include those currently 97 serving as volunteer members of the Temporary Commission established by Resolution 2018-98 16 and are still serving as of May 1, 2021. Volunteer members shall serve three-year terms, 99 with the capacity for reappointment. When a citizen member cannot complete his term or is removed from membership by the Mayor with approval of the City Council whenever, in 100 101 their judgment, the best interests of the Commission will be served thereby, the Mayor shall, 102 with the advice and consent of the City Council, appoint a replacement to serve the remainder 103 of that member's term.

- 105 B. Staff members. These members shall be appointed as described in § 25-51B 106
- 107 C. Council members. These members shall be appointed as described in § 25-51B and shall serve
 108 in accordance with their terms as members of the City Council.

110 § 25-54 Scheduling of meetings; recommendations and reports.

- A. The Commission shall meet as needed to accomplish the purpose set forth in § 25-50 of this article and provide a detailed report with recommendations to the Mayor and City Council. These recommendations shall be delivered in the form of a formal presentation of the event application to the Mayor and City Council.
- B. The Commission shall provide to the Mayor and City Council, prior or at the second
 regularly scheduled City Council meeting in August of each year, a post event assessment.

WHEREAS, on March 18, 2019, the Mayor and City Council of Havre de Grace, Maryland, 34 35 adopted Resolution 2019-02 supporting a Social Agreement "Twinning with Mumbles, Wales" which established and developed international community links that foster friendship, commerce, 36 37 education, tourism, awareness and understanding between the City of Havre de Grace and 38 Mumbles, Wales; and 39 40 WHEREAS, on October 7, 2019 the Mayor and City Council of Havre de Grace, Marvland, 41 adopted Resolution 2019-10 creating the Cultural Exchange Commission ("The Commission") to 42 further support the social agreement between the City of Havre de Grace and Mumbles. Wales and 43 review and recommend any future requests; and 44 45 WHEREAS, the City of Havre de Grace made its inaugural visit to Mumbles and signed the Official Twinning Charter on September 7th 2019, when a contingent of Havre de Grace Citizens. 46 including Mayor William T. Martin travelled to Wales to participate in the" Twinning" ceremony, 47 48 and 49 50 WHEREAS, as part of the" Twinning" agreement, the City of Havre de Grace was scheduled to 51 host a contingent of citizens in Havre de Grace from Mumbles in October 2020, however due to 52 the COVID-19 pandemic, the Commission hosted a virtual based visit, which included a week 53 long period in which citizens of Havre de Grace participated in live discussions as well as video 54 produced presentations; and 55 56 WHEREAS, Resolution 2019-10 stated that six months prior to the expiration of their terms, the 57 Commission shall advise the City of the Commissions status, and whether the Commission shall be extended, converted to a permanent City Commission, or replaced with a new tax-exempt 58 59 501(c)(3) corporation, and 60 WHEREAS, on April 28, 2021 the Commission determined and requested that the Mayor and 61 62 City Council of Havre de Grace create a permanent Havre de Grace Cultural Exchange 63 Commission to continue to move the concept of Twinning forward. 64 65 NOW THEREFORE, be it determined, decided, and ordained by the City Council that it is in the 66 best interest of the citizens of Havre de Grace, that a permanent Havre de Grace Cultural Exchange

Mr. Patrick Sypolt, Director of Administration: Mr. Sypolt shared information on upcoming City events.

Shane Grimm, Director of Planning: Mr. Grimm was absent from this evening's meeting.

George DeHority, Director of Finance: The current financial condition of General Fund 1, Water/Sewer Fund 9, and Marina Fund 8 were presented. The General Fund 1 balance is \$3,839,100 which is \$2,500,600 ahead of budget. The Water/Sewer Fund 9 is deficient of \$515,200, which is a \$206,700 increase year-to-date. The Marina Fund 8 balance is \$979,300, which is a \$153,600 increase year-to-date.

Tim Whittie, Director of Public Works: Mr. Whittie shared updates on current City projects.

Chief Teresa Walter, Havre de Grace Police Department: Chief Walter shared a quick reminder regarding the Special Olympics Maryland Torch Run is tomorrow, Tuesday, June 8, 2021, at 8:00 a.m. starting at the Lock House and North Park. This is for our Special Olympic athletes so they too can continue to participate in athletic competitions throughout the year. She wished to thank the Susquehanna Hose Company, Ambulance Corp, our City Code Enforcement, Mayor and the elected officials, and City staff for their support with the incident that occurred in our lobby. We have seen tremendous support for our Police Department from our community. We even had school students surprise us with posters for the officers supporting "our police department" and wishing us well and safety. PROCEEDINGS OF HARFORD COUNTY COUNCIL, GOVERNMENT, AND MUNICIPAL WORK SESSION- TOWN OF BEL AIR OF HARFORD COUNTY, MARYLAND

May 11, 2021

COUNCIL CHAMBERS

6:00 PM

<u>CALL TO ORDER</u> – Municipal Work Session was called to order at 6:00 PM by Council President Patrick Vincenti. All Councilmembers were present with the exception of Councilman Beulah (Councilman Chad Shrodes joined at 6:07PM and Councilman Joe Woods joined at 6:22PM). Other attendees were William Martin, Mayor, David Glenn, Council President, Jason Robertson, Councilmember, Casi Boyer, Councilmember, Jim Ringsaker, Councilmember, Carolyn Zinner, Councilmember, Stephen Gamatoria, Chief of Staff, George DeHority, Director, Tim Whittie, Director, Shane Grimm, Director, Billy Boniface, Chief Advisor to County Executive, Dr. Sean Bulson, Superintendent, and Cornell Brown, HCPS.

<u>OPENING REMARKS</u> – Council President Vincenti welcomed the other attendees and discussed the history of the Municipal Meetings. Councilman Wagner followed with similar remarks. Brief introductions were made by all who were present. Council President Vincenti invited Mayor Martin, Council President Glenn, and Chief of Staff Stephen Gamatoria to the presentation table to start the discussion items.

CITY OF HAVRE DE GRACE -

HARFORD COUNTY PUBLIC SCHOOLS – Mayor Martin requested to start with Harford County Public Schools as Redistricting is their top priority. He requested an update on the redistricting process. Cornell Brown replied that the redistricting group is meeting the following day (May 12th) as well as web maps being used will be updated on the HCPS website to reflect beginning of secondary enrollment processes. Mr. Brown elaborated on the redistricting process and discussed the proposed plans for students who reside in the Greenway Farms and Bulle Rock developments. The redistricting advisory board will meet with Superintendent Bulson on June 2nd to discuss their most recent findings from there, the advisory board will gather more information from the public feedback to incorporate into their final proposal to present to Superintendent Bulson. Brown restated that this process will not be completed until February 2022 which is when the final redistricting plans will be presented to the Board of Education (BOE) for a vote. Two public input sessions will be held. Mr. Brown stated that the advisory board is still working on the project and has received a lot of feedback on the public proposals from the community.

Council President Glenn asked how counts of students would be considered for enrollment numbers as the past year has been virtual learning. He also asked about boundary exception students. Superintendent Bulson replied that virtual student counts will be taken into consideration by using multiple data points to get enrollment numbers. Council President Glenn also mentioned the bus routes and asked how those will be affected with the redistricting process. Councilmember Robertson commented on the redistricting of Havre de Grace students going to Roy Williams Elementary School with hopes that the students can return to Havre de Grace for middle and high school. Mr. Brown replied that he will take those thoughts to the redistricting advisory board for consideration and that the transportation department would be reviewing the bus routes. Councilman Robertson then asked a question regarding restricted bus routes preventing them from crossing train tracks. Mr. Brown answered that this was a safety measure.

May 11, 2021

LSD 21-015

Councilmember Zinner proposed moving all pre-kindergarten students through second grade to Roy Williams Elementary School and then back to Havre de Grace Elementary for third through fifth grade. Superintendent Bulson replied that this model would cause potential issues in the future. The group had some discussion on the pros and cons of this method.

Councilmember Boyer commented on the conditions of Roy Williams Elementary School and the participation in the Patriot Program by students in Havre de Grace schools. She stated that she is concerned that students would not get the same experience being Havre de Grace Residents and going to school at Roye Williams Elementary. Mr. Brown replied to Councilmember Boyer by providing an update on the recent upgrades Roye Williams Elementary has received to its plumbing and HVAC systems. Council President Vincenti echoed these remarks and stated he recently toured the school and can confirm the updates to the facilities. Mr. Brown commented that the BOE is working with the State for more funding for facility updates. Council President Vincenti made a comment about Roye Williams Elementary School being a split articular school. Mr. Brown said that the school does have some students attend that will move on to Havre de Grace for secondary schools, but the majority is Aberdeen at this time, and this is something that they could look at as a possibility in the future.

Mayor Martin asked for an update on the status of the former Havre de Grace High School auditorium. Mr. Brown informed the group that they are still awaiting an official approval letter from the State of Maryland and that once this have been received, they can work with the County to surplus the building to the City.

DISCUSSION OF MUNICIPAL MEETINGS – Chief of Staff Gamatoria reviewed his experience and history of the municipal and county meetings in the past and offered to have the City of Havre de Grace host one in the future. Asked for a longer timeframe of the meeting in the future to enter into more depths of discussion.

TARC FUNDING – The City of Havre de Grace is seeking some assistance/support from the Harford County on the TARC Funds and would like to continue to keep a stable relationship. Mr. Gamatoria stated the benefits of having a closer relationship between the City and County. Mr. Gamatoria stated that the City would like to have support on TARC funding with city organizations such as the Opera House. He stated this funding will continue to increase the quality of performances that this organization is able to bring to the area.

POTENTIAL COUNTY LEGISLATION – Mr. Gamatoria discussed working with the County on the City's Route 40 clean-up efforts. The City hopes to get the Route 40 Gateways cleaned up and Mr. Gamatoria stated that the city is working closely with non-profits and small business to aide in this process. He requested that the county help with providing some type of leverage to get this process done at a timely manner such as requiring properties within a certain square footage of City limits to comply. Council President Vincenti commented that he received a letter from the City (as well as the Executive side confirmed by Billy Boniface) on this process and will follow up.

ELECTION REDISTIRCTING – Mr. Gamatoria commented on the need for good representation in the Councilmanic redistricting process. Mr. Gamatoria hopes that the group confirmed by the County Council will represent the citizens accordingly. Council Attorney Charles Kearney informed the group that the Redistricting Commission's first meeting is on May 19th.

HARFORD MEMORIAL HOSPITAL REPURPOSING – Mr. Gamatoria stated that the City has received documentation from the Cushman and Wakefield study but has not yet had a recent update on the plans. Director Shane Grimm confirmed that he met with representative of Cushman and Wakefield, David Baird within the last two weeks and there has been some interest on the project. Mr. Gamatoria commented that the City is working with the State of Maryland on incentivizing the project and would like to know if the County would be able to help with something similar.

FUTURE WATER NEEDS – Mr. Gamatoria mentioned the great relationship that the County DPW and the City have related to stormwater management. He also commented on the credits that have been achieved with various projects. Mr. Gamatoria discussed the living shoreline project that the City has upcoming,

Mr. Gamatoria stated that there is not a great relationship between the City and County on the water production side. He, along with Director Tim Whittie, provided an update to the group on the status of their project with the City of Aberdeen to build a 12-inch line and stated that a contractor, Allen Myers, has been selected. Mr. Gamatoria commented that the Rock Glenn community would be the first development serviced by this new project. Mr. Gamatoria informed the group that the County has asked that the City hold a supply reserve for their use in emergency situations. The City would like to pursue this with a formal contract with monetary compensation rather than a handshake agreement.

COUNTY COUNCIL SUPPORT -

Route 40 and Otsego Street Intersection- Mr. Gamatoria mentioned the current challenges with this intersection. Council President Vincenti replied that the County is aware of this project and has asked for State support for two years in a row in a presentation to the Harford County Delegation. Mr. Gamatoria asked for the County's continued support on this issue.

Admissions & Amusement Tax – Mr. Gamatoria expressed that the City is upset with the State for propositioning this funding be taken away. He furthered explained that this tax is important to Havre de Grace and explained the history of the Bulle Rock Golf Course at it related to the A&A Tax. Mr. Gamatoria informed the group that members of the Harford County Delegation have tried to place a moratorium on this tax two times.

<u>Emergency Response Crossing for CSX Railroad at Bleheim Farm Lane</u> – Mr. Gamatoria discussed the history of the railroad crossing bridge that existed on the property and stated how residents, the City and fire and EMS personnel would benefit greatly from having access. He also asked that the County provide assistance and support on this matter when the time comes.

ADDITIONAL DISCUSSION ITEMS – Mr. Gamatoria again offered to host a future meeting of this nature.

Council President Vincenti asked a question about the address of Roye Williams Elementary School and its assigned Student Resource Officer (SRO). Mr. Gamatoria replied that the school was not within the City limits of Havre de Grace.

Councilman Giangiordano asked for clarification on the CSX entrance into Blehiem Farm Lane. Mr. Gamatoria confirmed that no fire or EMS apparatus can get through there at this time.

Mr. Boniface discussed the County's excitement for the living shoreline project in Havre de Grace and provided the group with an update on the acquisition of Bell Vue Farms. Mr. Gamatoria stated that this project would offer some great opportunities to work with Eagle Scout projects.

May 11, 2021

<u>CLOSING COMMENTS</u>--- Council President Vincenti, Councilman Wagner, Mr. Gamatoria and Council President Glenn made closing comments. Council President Vincenti stated that the next meeting will be with the City of Aberdeen on June 8th.

97 98	e. The sign shall be removed upon the business ceasing operating at this location.
99	3. Indemnity.
100	The LICENSEE shall indemnify and save harmless the City and its employees and agents
101	from all claims and demands, suits, actions, loss, damages, recoveries, judgments, costs and
102	expenses in any manner arising out of or in connection with any injury, death, loss, or damage
103	related to the LICENSEE's use of the right-of-way, the LICENSEE's conduct, or the LICENSEE's

127 8. Entire Agreement.

130 The LICENSEE agrees that the City's failure to enforce any of the terms herein shall not131 constitute a waiver.

This is a Maryland contract and the parties hereto agree that the laws of Maryland shall apply to any disputes arising under the LICENSE. Harford County is the sole venue for any

11. No Assignment

137 This LICENSE may not be assigned by the LICENSEE without the express written consent 138 of the City Council in its sole discretion, which continuation may be permitted if the proposed 139 assignee continues the current use of the property for the remainder of the LICENSE term. Any 140 renewal of this LICENSE must in accordance with Resolution 2020-21 or any superseding 141 resolution or ordinance.

12. Specific Enforcement/Breach of Contract/Attorneys' Fees

In any legal action to enforce the terms of this LICENSE, for declaratory action, or to recover damages for breach of the terms of this LICENSE filed by any party, the City shall be entitled to recover reasonable attorneys' fees and costs from the LICENSEE or is successor or assigns for its successful prosecution or defense of such claims.
